### **Saginaw County Chamber of Commerce Corporate Community Service Award**

*- presented at the Annual Chairman's Ball -*

The Saginaw County Chamber of Commerce will recognize a Chamber member business/corporation in Saginaw County that has made a notable contribution to the quality of life in Saginaw County. This could take the form of volunteering personal time by persons employed by the company and/or financial support by the company to those activities that enrich, protect or entertain the citizenry of the County of Saginaw.

#### **CRITERIA**

Members of the Board of Directors of the Saginaw County Chamber of Commerce will determine the recipient of this award. The criteria will include, but not be limited to:

1. Involvement in community programs, activities or services (i.e. charities, youth programs, food banks, etc.)
2. Developing partnerships with the public sector, not-for-profits and the community to enhance community services and community life (collaborative efforts)
3. Achieved recognition of commitment outside of the nominee's area of business
4. The company documents a long-standing commitment to corporate citizenship as a preferred way of doing business (longevity of corporate giving)
5. Corporate citizenship must be a shared value of the company, visible at all levels
6. Corporate citizenship must be integrated into a successful business strategy

#### **NOMINATION PROCESS**

The Board of Directors of the Saginaw County Chamber of Commerce will be charged with nominating those businesses/corporations that are Chamber members that have met the above proposed criteria during the previous 24-month period.

Nominations may be accepted from non-Board Chamber members by contacting the Saginaw County Chamber of Commerce staff and/or Board members.

Nominees should have documented evidence of their dedication to community betterment activities. Examples of such documentation may include, but is not limited to the following:

- newspaper/magazine articles
- corporate sponsorship literature from events
- other corporate citizenry awards

- letters of support (no more than 2) from organizations or individuals that have directly benefited from the corporate support, photos, pamphlets, etc.

Nominations are due by April 30th of the current year. This will allow for research on nominees and selection of an Award winner to be conducted and determined in line with the planning activities for the Chairman's Ball.
